Pete Wright is co-founder of Wrightslaw and is an attorney who represents children with special education needs. Pete's determination to help children grew out of his own educational experiences. On October 6, 1993, Pete gave oral argument before the U.S. Supreme Court in Florence County District Four vs. Shannon Carter (510 U.S. 7 [1993]). Thirty-four days later, the court issued a unanimous decision for Shannon Carter. He is the co-author of Wrightslaw: *Special Education Law (1999), Wrightslaw: No Child Left behind (2003), Wrightslaw: IDEA 2004 (2005), and Wrightslaw: From Emotions to Advocacy, 2nd Edition (2005).*


